SUMMARY STATEMENT: The Board is being asked to approve new English Language Arts curriculum for Schoenbar Middle School.

ISSUE: Board Policy dictates that the School Board shall adopt curriculum for use in the district. Board Policy 6141 states, "the Board shall adopt a district curriculum which to the extent possible reflects the desires of the community, the needs of society, and the requirements of law," which is facilitated by the Curriculum Development and Evaluation committee process outlined in Administrative Regulation 6141.

BACKGROUND: The Secondary ELA Committee determined that its 11 year old curriculum and textbooks were in need of replacement due to new ELA standards and the poor condition of the existing textbooks. After reviewing products from McGraw Hill, Houghton Mifflin Harcourt, Amplify, and Savvas the committee selected Savvas's MyPerspectives curriculum for Schoenbar Middle School.
