SUMMARY STATEMENT:

The School Board is being asked to approve a 3-year subscription to IXL Learning to be used in KGBSD Schools.

BACKGROUND:

- IXL is a learning platform designed to provide curricular support, continuous diagnostic, personalized guidance for students, and real time analytics to help teachers identify the different instructional needs of each student.
- Will be used school-wide at Fawn Mountain, Point Higgins, and Houghtaling Elementary Schools, at Revilla for up to 25 students, and at Schoenbar Middle School for 30 students.
