The School Board is being asked to approve the \$36,000 purchase for a renewed subscription to the online Edgenuity curriculum.

ISSUE: Board Policy governs the district's purchasing procedures. Board Policy requires Board approval for expenditures and financial obligations over \$25, 000.

BACKGROUND:

This comprehensive online curriculum has been in our District for over a decade. It is the foundational curriculum that powers the Alaska Digital Academy (AkDA).
