SUMMARY STATEMENT:

The School Board is being asked to approve entering into a US Foods State of Alaska procurement contract for supplies for the District's food service program.

ISSUE: Board Policy governs the district's purchasing and contracting procedures. BP/AR 3312 requires contracts in excess of \$25,000 to be authorized by the School Board.

BACKGROUND: US Foods secured a Statewide Food Purchase and Delivery contract with the State of Alaska. KGBSD currently is on a local contract for food service with US Foods and purchases approximately \$360,000 on that contract. Moving to the Statewide Food Purchase and Delivery contract with US Foods will save the District approximately \$50,000 per year.

Term: August 1, 2022 through July 31, 2023 (with 7 one-year renewal options remaining).

The Office of Procurement and Property Management (OPPM), in partnership with the Department of Corrections, established this Master Agreement for the purchase of grocery, dairy, meat, and produce items with US Foods. This contract is mandatory for Department of Corrections in accordance with DOC's internal policy and non-mandatory for all other users.

Governmental entities eligible to use this master agreement include the Alaska Legislative Branch, Alaska Court System, University of Alaska, State Boards and Commissions, Federally Recognized Tribes and all State of Alaska political subdivisions including cities, boroughs, and school districts. Federally recognized tribes means native entity within the State of Alaska that is on the list published by the United States Bureau of Indian Affairs in 67 Federal Register, 463131-46333. Issues with interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Officer.

There are three lots; lot one for the South Central Region (Anchorage, Eagle River, Kenai, Palmer, Wasilla and Seward), for Southwest Alaska (Bethel, McGrath) and Northern Alaska (Nome), lot two for the Fairbanks Region, and lot three for Southeast Alaska (Juneau and Ketchikan).

Items and delivery provided to the appropriate agency shall be done in accordance with the terms, conditions, and specifications contained in the Limited Competition Solicitation 2021-9900-4796.
