• The District has been working on end of the year close-out processes ahead of the issuance of the final audit report for FY21 later this month. While the District's fund balance was protected in FY21 and some special revenue funds saw an increase in revenue to help offset existing deficits, the District has incurred another sizeable deficit in the Health Insurance Reserve Fund, and is recommending the alignment of resources to address this deficit in the short and long term.
