#### SUMMARY STATEMENT:

The School Board Policy Committee is proposing approval of revisions to Board Policy 4119.25.

## ISSUE/BACKGROUND:

Board Bylaw 9300 states that "The formulation and adoption of written Board policies shall constitute the basic method by which the Board shall govern the school district." Board Policy 0500 and Board Bylaw 9311 both address the ongoing review of district policies and programs by the School Board. The proposed revisions are in line with AASB suggested policy updates.

## POLITICAL ACTIVITIES OF EMPLOYEES

#### BP 4119.25

The School Board believes that district employees have an obligation to prevent the improper use of school time, materials or facilities for political <u>or partisan</u> <u>campaign</u> purposes. The Superintendent or <u>their</u> designee shall regulate political activities on school property <u>during the instructional day</u>. All employees are prohibited from engaging in any activity in the presence of students during performance of the employee's duties, where the activity is designed or intended to promote, further, or assert a position on any voting issue, board issue, or collective bargaining issue. This prohibition does not apply to classroom instruction that is part of the approved <u>curriculum</u>.

The Board respects the right of school employees to engage in political activities on their own time. When engaging in political activities, employees shall make it clear that they are acting as individuals and not as representatives of the district.

Violations of this policy may result in disciplinary action.

Nothing in the policy shall prevent the District or Board from disseminating factual information regarding school bond projects.
