The Ketchikan Gateway Borough Board of Education met in a regular session on the 14<sup>th</sup> day of September 2022, in the Ketchikan Gateway Borough Assembly Chambers. Board President Stephen Bradford called the meeting to order at 6:00 p.m.

Mr. Bradford welcomed Jack Zink, the new student member of the School Board to the meeting.

Mr. Bradford recognized Board member Diane Gubatayao for her award as an Alaska Children's Trust Champion for Kids 2022.

Mr. Bradford also recognized Kings for Peace. A group that was organized to facilitate a week of events surrounding the International Day of Peace, September 21<sup>st</sup> of each year. The Board and the public were invited to participate in an assembly on Thursday September 22, 2022 with a theme of "Meet the Moment."

She stated she was in full support of committee meetings and liaison discussions, but the reality was that an annual meeting of full government to government needed to be organized.
