

## Board of Education Meeting February 26, 2020 Superintendent Report

## Superintendent Remarks

Dear School Board Members.

The last two weeks have been very busy and exciting throughout KGBSD. On February 4, 2020, WISH was notified that they were selected and approved for the Victims of Crime Grant Program. As a partner with WISH and KIC, this grant will place a mental health expert and two behavior health aides (BHA's) at schools to provide services for our youth. In the coming weeks Mr. House, Ms. Bohlert and I will continue to meet with WISH and KIC representatives to work out the details and will notify as information is confirmed. We are currently working on a plan to begin services as soon as after spring break or not later than August 2020.

The district negotiation team met with the KEA negotiation team, and Administrative Assistant negotiation team. The teams have been meeting and reports from all sides are each meeting has been productive in establishing ground rules and reviewing information. During the days of February 20<sup>th</sup>, 21st and 24<sup>th</sup>, 2020 the teams reconvened to continue discussions. The KGBSD team will begin negotiations with IBEW in early March.

The Elizabeth Peratrovich Day Celebration's that took place at each school were wonderful. Each school celebrate Elizabeth Peratrovich legacy with activities that help children of all ages remember her as a civil rights leader. If you had the opportunity to attend one of the assemblies you were able to see celebrations through dance, song, drumming, poems, short plays, speeches and art.

On February 21, 2020 the high school seniors were able to ask questions directly to Senator Murkowski. Senator Murkowski attend in person through an invite by Government Teacher Ms. Stone. This opportunity provided Kayhi seniors the honor of being able to ask questions and learn about the many issues facing our nation.

Looking ahead, March 30- May 1, 2020 is the set dates for the PEAKS Assessment. Each school has set dates and times students will be taking the assessments. Parents can contact their students school for their students PEAKS Assessment dates and times.

The Performance Evaluation for Alaska's Schools (PEAKS) and the Alaska Science Assessment are designed to measure a student's understanding of the skills and concepts outlined in the <u>Alaska English Language Arts (ELA) and Mathematics Standards</u> and the <u>Alaska Science Grade Level Expectations - GLEs (pdf)</u>. The Alaska English Language Arts and Mathematics Standards are specific rigorous expectations for growth in students' skills across grades.

The Alaska English language arts (ELA) standards demonstrate the expectation that students' skills will build across grades in reading and analyzing a variety of complex texts, writing with clarity for different purposes, and presenting and evaluating ideas and evidence. The ELA standards are designed to help students develop a logical progression of fluency, analysis, and application, moving toward college and career readiness. The Alaska mathematics standards have the expectation that students' skills will grow across grades in mathematics content as well as mathematical practices. The mathematics standards are designed to help students develop a logical progression of mathematical fluency, conceptual understanding, and real world application.

The PEAKS assessments are administered to students in grades 3-9. The science assessment is administered to students in grades 4, 8, and 10.

As a reminder to school board trainings coming up. There will be a school board training on March 24 from 4:00 P.M. to 8:00 P.M. for all school board members provided by Timi Tullis and John Sedor from AASB. AASB has also confirmed they will be providing training in reviewing the results from the School Climate and Connectedness Survey May 13 from 4:30 P.M. to 5:30 P.M. On May 12 from 6:00 P.M. to 8:00 P.M. there will also be a community presentation.

This year the decision was made to improve our efforts in recruiting and retaining teachers. We continue our normal practice of advertising on Alaska Teacher Placement System (ATP). However, to improve and increase the recruiting efforts teams will be traveling to:
