SUMMARY STATEMENT:

The School Board is being asked to approve a contract with Three Dog Construction regarding Playground Groundwork, Soft-Surface and Equipment Installation at Houghtaling Elementary School.

BACKGROUND:

Through the competitive bidding process Three Dog Construction, Inc was identified as the apparent low bidder for the above referenced project on Oct 25, 2022. No appeals were received by the end of the ten-day appeal period 2:00 PM, Nov. 4th, 2022.
