

SUMMARY STATEMENT:

The School Board's approval is sought for student out-of-state travel for two students to attend an honor choir event in March 2020.

ISSUE:

Per Board Policy 6153, all school-sponsored trips to out-of-state locations require approval of the School Board.

BACKGROUND:

Two Kayhi Choir students, Robert Cope-Powell and Conner Wodehouse, were selected to attend the ACDA - NW (American Choral Directors Association - Northwest) honor choir in Spokane, Washington. The two chaperones are choir director Trina Purcell and Sean Powell. The trip dates are March 11 to March 15, 2020.


