SUMMARY STATEMENT: The Social Studies Curriculum Committee reviewed materials from a few vendors and selected the following vendors for the corresponding courses:

- 1. McGraw Hill for Street Law and World History (\$21,459.30)
- 2. Savaas for US History (\$12,256.82)
- 3. Bedford for AP U.S. Government (\$4,291.24)

ISSUE:

The materials for these subjects were in terrible disrepair and the content lack of e-licenses was becoming an issue.

BACKGROUND:

During the last social studies curriculum review textbooks were not ordered for these subjects, so many of the textbooks are actually over 10 years old.

RECOMMENDATION: Approve the social studies curriculum purchase for U.S. and World History, Street Law, and AP U.S. Government.
