ISSUE: Board Policy governs the district's purchasing and contracting procedures. BP/AR 3312 requires contracts in excess of \$25,000 to be authorized by the School Board.

BACKGROUND: Annually KGBSD works with an insurance broker (DBI) in order to obtain the best overall insurance products required by the State of Alaska and the Board of Education.
