Board Bylaw 9223 states that a vacancy on the Board shall be filled within 30 days of the seat being declared vacant. The seats were declared vacant when the Board accepted the resignations on March 26, 2025 for Michele O'Brien and April 2, 2025 for Keenan Sanderson.

If Sharon Montgomery is appointed to the Board, she will take the Oath of Office before being seated.

PLEASE ANSWER THE FOLLOWING QUESTIONS:

1. What is your reason for seeking an interim Board appointment?

As a lifelong resident and parent of two young children, I'm hoping to get my foot in the door to help our School District with the current issues we are facing, as well as future decisions to ensure our district keeps moving in the right direction. The recent resignations came at a critical time for our board and we need well-rounded and dedicated community members to step up and finish those terms. I believe I am an excellent candidate to hit the ground running in the short time we have left before the next election. My experience in business paired with my love for my hometown and my children will bring a balanced and fresh new skillset to the table.

2. What do you hope to accomplish as an interim Board member?

I hope to regain some confidence from our community and prove the Board is doing what is truly best for our students. I understand there is a strained relationship and a perceived sense of dishonesty from a number of citizens. I have always operated with integrity and taken pride in my beliefs and morals. I aim to use those values to prove to Ketchikan that the School Board also operates with honesty and ethics. While this position may only be for a short term, I understand the importance of making an impression and I hope to use this opportunity to gain support for a future seat on the Board.

3. What previous experience have you had serving on Boards?

Loyalty. I am loyal to Ketchikan as my hometown. I will devote the time and effort necessary to ensure this remains a great place to live and learn. I am loyal to my children. I will stand up for their rights and do what needs to be done to afford them the education they deserve. I am loyal to myself.
