SUMMARY STATEMENT:

Since about 2015 we have had some seasonal (late winter early spring) heaving and buckling of the Maple floor in the Gymnasium. It has raised 2 to 3 inches at times when the issue is prevalent. The floor lays back out to flat otherwise. A concern of injury when the distortion is present is the issue. Multiple unsuccessful attempts to address the problem have been tried. A site survey in summer 2022 identified a plan to rectify the problem. This consists of replacement of the existing floor with a mechanically affixed floor system. The School Board is being asked to approve a contract with Alaskan Industries, Inc for the Schoenbar Gym Floor replacement. No appeal was received on or before the deadline 9:00 AM March 20, 2023.

ISSUE: Board Policy governs the district's purchasing and contracting procedures. Board Policy requires Board approval for expenditures and financial obligations over \$25,000.00.
