Bylaws of the Board BB 9320(a)



MEETINGS:

Meetings of the Board are conducted for the purpose of accomplishing district business. A meeting of the Board shall consist of any gathering of the members of the Board when more than three members of the Board, or a majority of the members, whichever is less, are present and collectively consider a matter upon which the Board is empowered to act. As a matter of district policy and state law, meetings ordinarily shall be open to the public. The Board may meet in closed sessions only to discuss certain matters as permitted or required by Alaska's Open Meetings Act. (cf. 9321 Executive Sessions) Reasonable public notice shall be given for all meetings of the Board in accordance with law and district practice and shall be posted at all regular district and school sites before the meeting. Such notice shall include the date, time, and place of the meeting and, if the meeting is by teleconference, the location of any teleconferencing facilities that will be used. (cf. 9322 - Agenda/Meeting Materials) (cf. 9323 - Conduct of Meetings)

Regular Meetings: The Board shall: 1. Hold at least one (1) regular meeting, per month. 2. Additional meetings or work sessions of the Board may be called in accordance with the remaining provisions of these Bylaws. 3. Convene all regular meetings at 6 p.m. at the Ketchikan Gateway Borough Assembly Chambers when available, unless another location is designated by the Board. Notice of regular meetings shall be posted at least five (5) days prior to the meeting.
