To Beth Lougee, Superintendent, Katie Parrott, Business Manager, and member of the School Board:

Our board wants to thank you for your continued support of our program by approving funding for FY 2020-2021. However, the COVID-19 pandemic has once again exerted its influence on our program.

We recently received notification from the Gero Education Department in Japan that they have postponed the contract for the upcoming Japanese exchange teacher until next year's school term. The pandemic in Japan has caused the US Consulate in Osaka to indefinitely postpone the interviews required for the teacher to receive his visa for entry into the US. In addition, the Japanese government still has a Level 4 travel advisory for its citizens, and with the situation here in the United States it is doubtful that this would be changed prior to this year's school start.

Gero has been in contact with Sheri Boehlert, Principal, at Schoenbar Middle School concerning this postponement; Ms. Boehlert has been understanding with the concerns, especially since plans for the upcoming school year are still being discussed.

The funding from the school district helps pays the salary of the exchange teacher from Ketchikan working in Gero/Kanayama schools. In return, Ketchikan has a teacher from Gero working here in our schools. This mutual teacher exchange has been part our program from the beginning. With no Japanese teacher arriving this year, we have also postponed the contract for our exchange teacher, Matt Armstrong, who was set to travel to Japan in August. As a result of these decisions, we cannot, in good faith accept the approved funding for fiscal year 2021.

We do earnestly hope, however, that is in no way would affect any consideration for our future school funding. We have all hope of being able to resume the exchange program next year.
