**CALL TO ORDER; PLEDGE OF ALLEGIANCE; ROLL CALL**

The Ketchikan Gateway Borough Board of Education met in a government to government consultation with Ketchikan Indian Community's Tribal Council on the 16th day of June, 2021, beginning at 5:30 p.m. in the Shaa Hit Room at Cape Fox Lodge.

The following members were present and due notice had been published: Board President Kim Hodne; Vice President Diane Gubatayao; Clerk-Treasurer Bridgett Mattson; and Board Members Paul Robbins Jr. and Douglas Gregg.

*KIC Tribal Members present were: Gloria Burns, President; Melissa Johnson, Secretary; Trixie Bennett, Member, Lloyd Ruaro, Member; and Chas Edwardson, Member.*

Board President Kim Hodne recited the traditional lands acknowledgement.

**Government to Government Consultation**

The government to government consultation was held in a worksession<sup>1</sup> format with no action taken and discussion only occurring between the two bodies.

The following subjects were included in the evening's discussion: the Title VI grant; notification and consultation with the Tribe regarding other Title grants funded at more than \$40,000; a potential future training on ESSA<sup>2</sup> in regards to government to government consultation; the Alaska Cultural Curriculum Standards and addressing cultural disconnect in the district; Tribal input regarding those individuals teaching under a "cultural" Type M certificate; requests for data on Native students, such as the number on IEPs; plans for recruiting and hiring more Native teachers; plans for addressing the dropout rate; KIC's strategic planning as long-range, including up to 100 years; and the future consultations between the two bodies.

The session ended at 8:19 p.m.
