****PUBLIC HEARING** BUDGET**

President Bradford presented a laid on the table document which contained specific dollar amounts within the full proposed budget.

M/S: SANDERSON/HEUTTE on Motion for the Board of Education to approve the draft FY 2024-2025 proposed budget in the amount of \$38,491,312 for the operating fund and \$7,247,822 for the special revenue fund for the combined total amount of \$45,739,134 and also move that the school board request a combined \$11,790,456 in the funding from the Ketchikan Gateway Borough Assembly, in second reading.

No citizens commented during the public hearing.

DISCUSSION:

Business Manager Schuler and the board held a discussion about the proposed budget was based on the known educational funding and would not be able to change unless there was additional funding awarded by the State of Alaska. This proposed budget would lay off approximately 44 positions district wide. If additional funding became available, positions would be restored as possible. Debt repayment to the Borough regarding the health care deficit, was built into the proposed budget.
