SUMMARY STATEMENT:

The School Board is being asked to approve a contract with Jungle Jim's Floorcovering @ 5650 Old Seward Hwy, Suite F Anchorage, Alaska 99901. for \$99,907.00. Ketchikan Gateway Borough School District entered a competitive bidding process for this project on July 22, 2024. Jungle Jim's Floorcovering was identified as the low bidder at the scheduled bid opening at 2pm on August 13, 2024. This is a Ketchikan Gateway Borough facilities capital funded and approved project.

ISSUE: Board Policy governs the district's purchasing and contracting procedures. Board Policy requires Board approval for expenditures and financial obligations over \$25,000.00.

BACKGROUND:

In 1999 Houghtaling Elementary had a complete mechanical upgrade. During that process a commercial grade flat rolled vinyl floor-covering was installed in the Houghtaling Gymnasium. That flooring has come to the end of its 25 year service life and is need of replacement. The old flooring has become increasingly harder to repair. At times between repairs the splits and cracks can be tripping and scrapping hazards.
